Glory be to God. Isaiah 43:19 Behold, I will do a new thing; now it shall spring forth; shall ye not


know it? I will even make a way in the wilderness, and rivers in the desert. KJV

Just before Christmas, with some time on my hands, I took a little jaunt down into a nameless holler.

It was one of those unseasonably warm days we've had, so I only had on flannel shirt. I slipped and tripped on the way down until I hit flat ground around the creek at the bottom. It was mostly silent and gray overhead, no birds or critters visible at mid-day. The creek gets little to no sunlight in the winter, but it remains green with thick moss on the fallen, decaying trees and rocks. Instead of trying to maneuver over the deadfall and vines, I followed the dry limestone creek bed to the spring.

I discovered the spring several weeks before, and on this day it was still gushing after a recent rain.

I decided to make my journey to visit its source up the steep hillside. It was no easy going through

the vines, fallen trees, and loose rock, but the slow ascent was revealing. The stream would run at an incline for several yards, then flow over a rock shelf, creating a little waterfall. I find the sound of running water soothing, so I took several pauses to just sit and listen. Eventually I found myself amidst car-sized boulders, and the surrounding hillside was finally impossible to walk. The spring stream gushed at an even higher rate than below. I really couldn't travel any further

on foot.

I shimmied myself over the rocks (if you can imagine someone my size shimmying), and I eventually found myself a relatively flat place to sit. The area was covered with thick vines and underbrush, and I couldn't further trace the spring, at least not without a machete – or a chainsaw. I was a few dozen yards from the top of the ridge, so I just enjoyed my seat and the view below me and across the holler. As I settled into silence, I heard crows

cawing to one another on the opposite ridge. A light breeze pushed through the holler.

Instead of retracing my steps, I followed a path laid by our deer neighbors through a thick cedar forest. A slight shelf runs along that side of the holler, which the deer and other critters use. Cedar and other evergreens tend to dampen sounds, so it was a silent trip through the trees, which caressed and combed my arms and head, leaving needles

down my shirt and on top of my head. The cedars eventually thinned, and I emerged in a dense thicket which soon led back to my entry point into the holler. The journey completed, I made my way back home.

I feel fortunate once again to have a new stretch of countryside to explore. I miss the woods I grew up with, but there's always another new trail to find and follow.
