added until further notice. Persons seeking to enroll in the Home Delivered Meal will be placed on a wait list and will be contacted as soon as funding is restored and enrollment can continue. “Operations of GADD’s Home Delivered Meal Program will remain unchanged for current participants,” Farrow said in the release.

He further explained “The changes are intended to more responsibly align program expenditures with available funding while preserving the long-term availability and stability of nutrition services for older adults throughout the Gateway region, and also supporting the needs of the staff who provide these important services.”

In July, GADD announced that due to the funding shortfall, their MotorMeals program was indefinitely suspended on August 1.

In response, Gov. Andy Beshear announced later in July that an additional \$4 million would be released for senior nutrition programs in the state.

Farrow said at the time, “This will have an immediate impact on the region. Of the \$4 million in additional funding, GADD’s share is approximately \$250,000 in direct service funds. However, a budget shortfall for the region still exists.”

On Monday, Farrow noted in the press release, “GADD will continue to evaluate funding availability and program needs as the fiscal year progresses. The organization remains committed to providing quality nutrition services and supporting the health, independence, and well-being of older adults throughout Bath, Menifee, and Rowan counties.

All senior meal programs across the state were also affected in September 2025 by a similar budget shortfall. However, at the time, Gov. Steve Beshear worked with the General Assembly to find unused funds to restore the needed funding.
