than holding a title. She emphasized her working relationships with state officials and neighboring county leaders, which she believes are critical for a small, rural river county like Carlisle. "Our communities can too often be overlooked," she said, crediting current river county judges for ensuring local voices are heard at

the state and federal levels. Galloway said she has learned from that leadership and is committed to continuing cooperation and advocacy on behalf of Carlisle County. She added that her experience has given her a comprehensive understanding of county government and the difficult decisions required of the office. **Priorities if Elected:**

If elected, Galloway said maintaining day-to-day operations, current projects and road maintenance would remain top priorities. She also identified economic development as a major focus. "Our tax base has continued to decline," she said, noting that Carlisle County is well positioned for growth due to access to rail and water transporta-

tion and proximity to Interstates 57 and 24. Galloway said leveraging these assets is key to attracting investment, expanding the tax base and promoting sustainable economic growth.

Galloway said she plans to engage with residents by being present, accessible

and responsive. Her approach includes attending community events, listening to concerns and working directly with residents and local leaders. Residents Say Goodbye to Arlington First Baptist Church

ARLINGTON — Arlington's First Baptist Church, with a rich history dating back to the early 1900s, was recently taken down,

marking the end of an era for longtime members. The decision was not made lightly. Church treasurer Cynthia Hocker explained, "The old church had many problems, including

being inaccessible to those with disabilities, as well as issues with heating and cooling, among others." She added, "There will be more fundraisers in the future for the new building, which

will be constructed at the same location." During the demolition, the church's concrete sign was removed, revealing a remarkable piece of history: a time capsule dating back to the

1920s, stored inside an old canning jar. The capsule contained newspaper clippings, names, and other artifacts documenting the church's long legacy. The congregation held its final service

in the sanctuary in late 2025 or early 2026, marking a significant transition as they look forward to a new building and the next chapter in their community's history.

Arlington Council Discusses Gas Contract, Ballpark Plans

ARLINGTON — The Arlington City Council held its monthly meeting on January 12th at 5 p.m. Mayor McGee welcomed attendees, which included Clerk Anya Carol Carter, council mem-

bers Nancy Dodge and Evelyn West, and visitor Lilly Morefield with the Carlisle County News. Following the Pledge of Allegiance, last month's minutes were approved. The financial report was reviewed and approved after a motion by Dodge, seconded by Carter. Similarly, a motion by West, seconded by Dodge, to approve the city bills was carried.

In the sanitation report, Carter noted that a new pump along Highway 51 was discussed at the meeting, though no decision was reached. Dodge provided an update from Commonwealth Gas, stating that the council may want to explore securing a contract with the company. The Knights of Columbus had suggested the city may

discussion, the council agreed to consult a lawyer to determine whether a contract is necessary. Mayor McGee noted that the city had a contract in the past but was recently informed it was no longer required.

Under new business, the council discussed the old ballpark building. Mayor McGee stated the structure is in poor condition and cannot be repaired. The council considered hiring someone to remove it and scrap the tin from the roof, with the city receiving a small payment for each layer of tin. A decision and resolution regarding the project will be made at the next meeting, along with a public notice for bids. The meeting was adjourned following a motion that carried unanimously.
