The Allen County Board of Education is proposing a general fund tax levy of **46.3 cents on real property and 53.3 cents on personal property.**

The General Fund tax levied in fiscal year 2026 was 48.0 cents on real property and 53.3 cents on personal property and produced revenue of \$7,394,031.84. The proposed General Fund tax rate of 46.3 cents on real property and 53.3 cents on personal property is expected to produce \$7,988,638.89. Of this amount, \$1,045,606.87 is from new and personal property. The compensating tax for 2027 is 44.6 cents on real property and 53.3 cents on personal property and is expected to produce \$7,733,058.55.

The proposed rate is expected to generate more revenue than received in the preceding year. The general areas to which revenue of \$594,607.05 above fiscal year 2026 revenue is to be allocated are as follows: Cost of collections, \$17,838.21; building fund, \$215,260.35; instruction, \$260,286.11; transportation, \$28,920.68; and maintenance of plant, \$72,301.70.

This information is published pursuant to KRS 160.470. The proposed tax rate is not subject to recall under KRS 132.017.

2026 Proposed Tax Rate Public Hearing

The Allen County Fiscal Court will hold a public hearing on September 3, 2026 at 6 p.m. in the fiscal court room of the city county building for the purpose of obtaining comments from the public regarding the proposed tax rate and the setting the tax rate.

The tax rate levied last year was 7.1 cents per \$100 value and produced revenues in the amount of \$967,104.00. This year's compensating rate is 6.5 cents per \$100 value and will produce revenues in the amount of \$977,219.00. The Allen County Fiscal Court proposes to lower the tax rate to 6.7 cents per \$100 value which will produce a total of \$1,007,287 in revenues.

Revenue expected from new property is \$2,572.01; revenue expected from personal property is \$134,982.56; revenue expected from motor vehicles is \$189,944.08; and revenue expected from watercraft is \$8,237.03.

Revenue received in excess of last year's will be used for operation of the Allen County Detention Center.
