

# Ky. GOP pair call for term limits — 1 federal, 1 for the statehouse

FRANKFORT — Two Kentucky Republicans in the GOP-controlled General Assembly are proposing term limits on lawmakers — one at the federal level and one for themselves.

Rep. Kim Banta, R-Fort Mitchell, has filed a bill that would put the question to Kentucky voters in the form of a constitutional amendment imposing term limits on state legislators. Meanwhile in the Senate, Majority Floor Leader Max Wise, of Campbellsville,

filed a resolution that would add Kentucky to states seeking a national convention to propose an amendment to the U.S. Constitution imposing term limits on members of Congress.

Asked about both proposals Tuesday, House Speaker David Osborne, R-Prospect, told reporters that lawmakers already have term limits — elections.

“Every two years we have elections. You look at the turnover of this body over the last six years, we have about 80 members that have served four terms or less. So, I think we

have pretty effective term limits,” he said. “But that said, we will certainly look at them and discuss with the caucus and see what the

will of the caucus is.” Kentucky lawmakers are meeting for the second week of the 2026 legislative session, and neither bill has been given a committee hearing at this point. Both

have GOP co-sponsors. Banta said that she’s supported term limits since she began serving in the House in 2019. She added that she filed similar legislation in the past.
