where, even in that short window of time, one of the worst-case scenarios unfolded — an air conditioner in the living room caught fire, said Taylor.

Brantley, age 10, witnessed what happened, and hurried to go get get his siblings — Laiken, age 9, and 17-year-old Kaylynn, whose disability would have likely prevented her from being able to escape on her own.

“He got my daughter out of her room just in time, before it blew up, literally right behind him,” said Taylor, her voice full of emotion as she recalled what had happened.”

Martin said that it appears that the air conditioner may have overloaded the socket it was plugged into.

He noted that Burnside Firefighters were on the scene for about two hours with assistance from the Parkers Mill Fire Department and the Ferguson Fire Department, with a call from the City of Somerset as well.

“(Because of the) time of day, we didn't have a whole lot of volunteers around,” said Martin.

Taylor stressed how “absolutely” proud she was of Brantley for thinking fast, despite the stress that the situation put on his young mind.

“He's very mature for a 10-year-old,” said Taylor. “He's very responsible, but especially in a situation like that where there's panic, just to know that's the first thing that hit his mind was to get her out, I just can't put into words how proud I am of him.”

She added, “He just said, ‘Mom, I tried to put the fire out.’ He had a glass of water that he was drinking and he threw it on (the fire) and he said it didn't do anything. He went to get a second refill from the kitchen and he said it just kept getting bigger, so he knew that wasn't going to work.”

After that, Brantley knew he had to get Kaylynn out and to safety — and did so successfully, with no injuries to any of the youth.

The house, unfortunately, did suffer extensive damage.

While Martin indicated that it wasn't a total loss, Taylor said that while looking from

outside, one wouldn't think the house was unsalvageable, the scene inside tells a different story.

“If the heat and the fire didn't ruin it, the smoke just ruined everything,” she said.

Making it worse, the Taylors had just paid off the house they'd lived in for 15 years.

“The landlord was an amazing guy. We had never owned anything before. I guess he saw a young couple just trying to make it from nothing,” said Taylor. “We both come from absolutely nothing.”

Taylor said there was no insurance on the house, making the recovery process all the more difficult for the family.

“It was taken from us,” she said of the home.

Currently, the family is staying in a camper on some land owned by Taylor's mother with an electric generator. The kids are split up, staying with different family members and friends to give them better temporary living situations.

There is a GoFundMe page set up to help the fam-

ily. Under the name “Rebuilding Hope for a Family After the Fire,” started by Rebecca and Robert Karst (<https://tinyurl.com/5hexmmad>) of R&R Mobile RV Repair, Casey's employers. “They're like family to us,” said Taylor.

Others in the community have helped out as well. South Central Athletics has been taking up donations, as have Burnside Elementary, Southern Middle and Southwestern High Schools and a few local churches like Potters Place, Neely's Creek Missionary Baptist, and Saline Baptist.

Taylor said the family is actively getting donations of clothing and hygiene necessities, but if anyone else would like to contribute to help, they can contact Brittny Taylor via her Facebook page or at 606-516-8344.

“I am overwhelmed at the amount of support we have gotten so far,” said Taylor. “I did not expect to have a village behind us because we didn't think we had anybody, so it is humbling to be in a community like this.”
