The University of Louisville Department of Theatre Arts Presents The Laramie Project A Documentary Play Examining the Legacy of Matthew Shepard Louisville, KY — The University of Louisville Department of Theatre Arts is proud to present The Laramie Project, the groundbreaking documentary play by Moisés Kaufman and members of the Tectonic Theater Project. Created in response to the 1998 murder of Matthew Shepard, The Laramie Project stands as one of the most significant works of documentary theatre addressing anti-LGBTQ+ violence in the United States. Developed from more than 200 interviews conducted by the theatre company in the months following Shepard's death, the play gives voice to a wide range of perspectives and explores how a small town—and a nation—grappled with grief, prejudice, and the urgent call for greater understanding and equality.
