CITY OF JEFFERSONTOWN JEFFERSON COUNTY, KENTUCKY ORDINANCE NO. 1481, SERIES 2026

AN ORDINANCE RELATING TO A PROPOSAL TO ANNEX TO THE CITY OF JEFFERSONTOWN, KENTUCKY TWO TRACTS OF LAND, TRACT I APPROXIMATELY EASTERLY AND TRACT II APPROXIMATELY WESTERLY, BOTH IN THE COUNTY OF JEFFERSON, AND BOTH ADJOINING THE PRESENT CITY OF JEFFERSONTOWN, KENTUCKY, AND BEING ADJACENT TO AND CONTIGUOUS WITH TRACT I BEING ADJACENT AND CONTIGUOUS GENERALLY NORTHERN AND EASTERN AND A TRACT II BEING ADJACENT AND CONTIGUOUS GENERALLY SOUTHERLY AND WESTERLY, AND BOTH BEING ADJACENT AND CONTIGUOUS WITH THE PRESENT BOUNDARIES OF SAID CITY AT THE SAME POINT ON CHENOWETH RUN ROAD AND TAYLORSVILLE ROADS AND MORE PARTICULARLY HEREIN AFTER DESCRIBED

WHEREAS, attached to this Ordinance are petitions in favor of the proposed Annexation signed by a number of registered and qualified voters residing in the areas proposed to be annexed which is equal to or exceeds seventy-five percent (75%) of the total number of votes cast in the areas in the last preceding presidential election; and,

WHEREAS, the petitions also contain more than fifty-one (51%) percent of all owners of real estate within the limits of the territory to be annexed; and,

WHEREAS, the annexation area is adjacent to and contiguous to the existing boundary of the City of Jeffersontown; and,

WHEREAS, because the boundaries of the proposed annexation area are proximate and contiguous to the City's multi-million-dollar amphitheater, which is situated within the City of Jeffersontown, Kentucky, the land is urban in character and suitable for development for urban purposes and the City can provide services without any delay; and,

WHEREAS, no part of the annexation area is included within the boundary of another incorporated city; and,

WHEREAS, the number of registered and qualified voters required by KRS 67C.111(3), and the percentage of real property owners required by KRS 81A.420 to estop a petition in opposition to the annexation, have requested this annexation.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF JEFFERSONTOWN, KENTUCKY, AS FOLLOWS:

Section 1. It is deemed desirable to annex to the City of Jeffersontown, Kentucky, and extend the boundaries of the City of Jeffersontown in two tracts, to wit: Tract I: extending easterly and northerly; and Tract II extending southerly and westerly to include same, that certain tract of land which is now embraced within the County of Jefferson and which is adjacent to and contiguous with the present city boundary at Chenoweth Run Road and Taylorsville Road which, by reason of population density and land hold improvements is urban in character and suitable for immediate development, which tenit01y is accurately described and defined as follows on the attached Exhibits A and B.

Section 2. The zoning on the subject property shall remain as currently zoned, LC44400500.

until changed by the City of Jeffersontown.

Section 3. Pursuant to KRS 81A.425, the City Clerk is instructed to prepare and celiify a list of the owners to whom notice was sent; and, said notice shall be sent via USPS first class mail no later than fourteen (14) days prior to the meeting at which the Ordinance Proposing annexation shall receive its second reading.

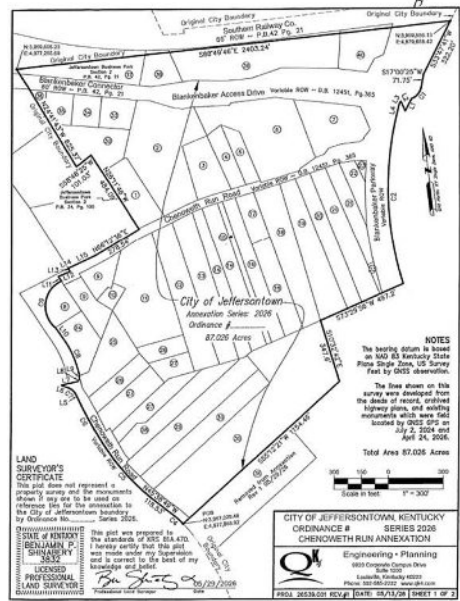
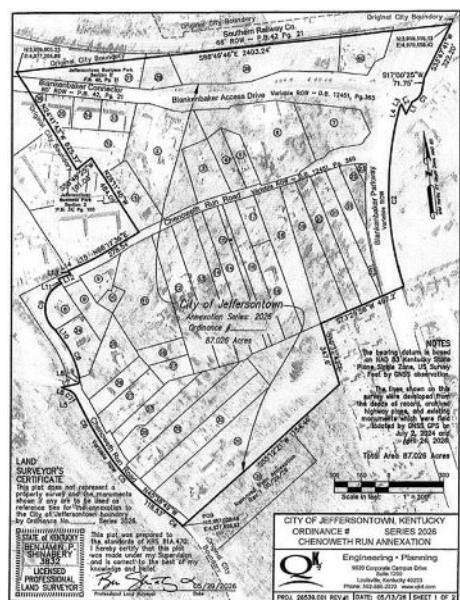
Section 4. The City Clerk is authorized and directed to publish this Ordinance under KRS Chapters 81A, 83A, and 424.

Section 5. This Ordinance shall take effect from and after its passage, signing and publication as required by law.
