AN ORDINANCE RELATING TO REQUESTING THE APPROVAL BY THE LOUISVILLE/JEFFERSON COUNTY METRO COUNCIL OF THE ANNEXATION BY THE CITY OF JEFFERSONTOWN OF TWO TRACTS OF LAND, TRACT 1 APPROXIMATELY EASTERLY AND TRACT 11 APPROXIMATELY WESTERLY, BOTH IN THE COUNTY OF JEFFERSON, AND BOTH ADJOINING THE PRESENT CITY OF JEFFERSONTOWN, KENTUCKY, AND BEING ADJACENT TO AND CONTIGUOUS WITH TRACT 1 BEING ADJACENT AND CONTIGUOUS GENERALLY NORTHERN AND EASTERN AND A TRACT 11 BEING ADJACENT AND CONTIGUOUS GENERALLY SOUTHERLY AND WESTERLY, AND BOTH BEING ADJACENT AND CONTIGUOUS WITH THE PRESENT BOUNDARIES OF SAID CITY BUT NOT CONTIGUOUS TO THE BOUNDARY OF THE FORMER CITY OF LOUISVILLE, AND BEING IN THE UNINCORPORATED AREA OF THE FORMER COUNTY OF JEFFERSON

WHEREAS, the City of Jeffersontown seeks to annex the following described tracts of land (with improvements) which tracts are not contiguous with the boundary of the former City of Louisville and more particularly described in Exhibits "A" and "B" (attached); and,

WHEREAS, an amount equal to more than ninety-five (95%) percent of the registered and qualified voters who voted in the last presidential election, and seventy-two-point four (72.4%) percent of the property owners residing within the annexation area have executed their written consent to the subject annexation by the City of Jeffersontown; and,

WHEREAS, the City of Jeffersontown is ready and able to immediately begin furnishing municipal services to the area upon annexation of the area; and,

WHEREAS, the number of registered and qualified voters required by KRS 67C.111 (3) and the percentage of real property owners required by KRS 8 1A.420 to estop a petition in opposition to the annexation have requested this annexation; and,

WHEREAS, KRS 67C.111 (3) requires that the annexation receive the approval of the legislative council of the consolidated local government (the Louisville/Jefferson County Metro City Council) prior to the City proceeding under the provisions of KRS Chapter 8 1A.412.

NOW THEREFORE, BE IT ORDERED BY THE cvrv OF JEFFERSONTOWN, KENTUCKY, AS FOLLOWS:

Section 1. The City of Jeffersontown hereby seeks and requests the approval of the Louisville/Jefferson County Metro Council of the annexation of that certain property depicted in Exhibit "A" and more particularly described therein, which Exhibit is incorporated herein by reference as if set forth in full.

Section 2. The individual parcels identified collectively in Section 1 are contiguous with one another, and are collectively contiguous with the City of Jeffersontown and are urban in character. The owners of the parcels, being registered and qualified voters, and equaling seventy-two-point four (72.4%) of the number of registered and qualified voters who voted in the last presidential election have consented in writing to the requested annexation.

Section 3. Copies of voter registration of voters who voted in the last presidential election are attached as Exhibit "B".

Section 4. This ordinance shall take effect upon its adoption and publication as required by law.
