PUBLIC NOTICE REGISTERED PERMIT-BY-RULE

Daniels SharpSmart, Inc. proposes to submit an application for a registered permit-by-rule Medical Waste Transfer Station facility to the Energy and Environment Cabinet, Division of Waste Management, pursuant to 401 KAR 47:110. The registration shall become effective five (5) business days after the cabinet receives it, with the exception of medical waste transfer stations which become effective thirty (30) days after the cabinet receives it, unless the cabinet denies the registration within that time.
