Sealed proposals for the construction of the Brownsville Sewer System Additions will be received at the office of Caveland Environmental Authority, Inc., 508 South Dixie Highway, Cave City, Kentucky 42127, Attention: David Peterson, CEO on or before 10:00 a.m. local time on Wednesday, April 15, 2026, and immediately thereafter all bids will be publicly opened and read aloud.
The project will include the following described construction:
The furnishing, installation and testing of approximately 30,875 linear feet of 6-inch C900 DR21 PVC sewer force main; 3,450 linear feet of 4-inch C900 DR21 PVC sewer force main and 825 linear feet of 6" DR11 HDPE force main in directional bore; three (3) wastewater pumping stations, including all manholes, valves, air release valve assemblies, fittings, sewer and force main connections, unclassified excavation, backfill, tie-ins, restoration, pavement restoration, bores, steel casing pipes, testing, detection tape and trace wire, and all other appurtenances and other work as shown on the Construction Drawings or indicated in the Contract Specifications.
The Additive Alternates (if authorized by the Owner) will include the following described construction:
Additive Alternate 1: WWTP Pump Station Emergency Diesel Generator and Automatic Transfer Switch.
