EDMONSON COUNTY FISCAL COURT PUBLIC NOTICE

PUBLIC HEARING REGARDING PROPOSED USE OF COUNTY ROAD AID AND LOCAL GOVERNMENT ECONOMIC ASSISTANCE (LGEA) FUNDS

A public hearing will be held by Edmonson County Fiscal Court at the Edmonson County Courthouse, 110 E. Main Cross Street, Brownsville, KY 42210 on June 22nd, 2026 at 3:45 p.m. for the purpose of obtaining citizens comments regarding the possible uses of the County Road Aid (CRA) and Local Government Economic Assistance (LGEA) Funds.

Edmonson County anticipates the receipt of CRA Funds for the Fiscal Year 2026-2027 to be approximately \$975,947.00 which will be used for the construction, reconstruction, and maintenance of county roads.

Edmonson County anticipates the receipt of LGEA Funds for the Fiscal year 2026-2027 to be approximately \$12,000.00, which will be used for Economic Development, Protection to the Persons and Property, Social Services, and Recreation and Culture.

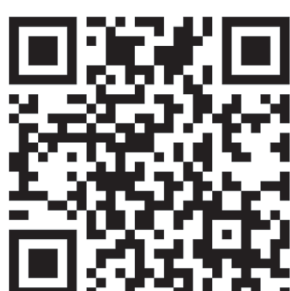

Jeanes-Smith, contacted the News-Herald. Smith was allegedly staying at the recreation area during the incident and said the tent was located at campsite C6. She claims park employees told campers the site was not registered and also alleges she heard a vehicle leave the area around 3 a.m.

"There were other people staying around us as well, so the vehicle we heard leaving around 3 a.m. may have had no connection at all," Smith said. "It just seemed like an unusual

time for someone to be leaving...I just wanted to make sure the story was shared so that if anyone does have more information, they know to come forward."

Kentucky State Police have not confirmed those details, and authorities have released no information regarding the cause of death and/or any injuries.
