now there are 6.

The District in total now has 26 employees. The pumps were replaced, SCADA was installed, flow rates are monitored better which makes things more efficient. Computers were installed at the lake to monitor when water was released and the quality of the water. UV Lights are going to be installed to kill more bacteria in the water. A new generator will also be installed to make sure the plant never loses electricity.

Brown says in 24 months Edmonson will have one of the most state-of-the art water plants in the state, and fully expects Edmonson County Water District to start winning awards for the best water around.






