

Fire departments quickly suppress log truck fire

At 7:58 a.m. Monday, an all-tone was issued for Stanton Fire, Middle Fork Fire, and Clay City Fire after reports of a log truck fire in Stan-

ton.

The cab of a large tandem log truck, loaded with timber and positioned beside multiple diesel fuel tanks, was fully engulfed in flames when firefights

ers arrived.

The Stanton Fire Department was first on scene and confirmed that the cab was completely engulfed in flames. With fuel tanks and heavy logs nearby,

the situation had the potential to escalate rapidly. Fire crews worked diligently to extinguish the blaze and protect the surrounding fuel structures.

Stanton Fire Chief Jimmy McIntosh responded to the scene, coordinating Stanton's initial suppression efforts. Stanton's Chief of Police also arrived and assisted on scene, ensuring roadway and scene safety for responders.

The owner of the truck, Mr. Burchfield, reported that he had started the vehicle moments earlier and stepped away briefly. When he returned, the

cab was already engulfed. One male subject suffered non-life-threatening injuries during the incident. No other injuries were reported.

The Middle Fork Fire Department also arrived to assist, with firefighter Quinton Campbell on scene providing additional manpower and support.

Clay City Fire Department was toned out as well, with Assistant Chief Jesse Allen responding with a tanker.

Even after Stanton radioed to reduce response, Clay City continued in with water support, noting that "you never know when extra water becomes the difference."

Despite the severity of the blaze, only the cab of the truck was destroyed. The logs did not ignite, and the diesel tanks did not

become involved — a critical outcome given the proximity and fuel load present.

At the owner's request, an arson investigation was initiated. Kentucky State Police responded to the scene immediately, and the fire remains under investigation by KSP arson detectives.

All units cleared the scene at 8:56 a.m.

This incident highlights the strength of multi-agency cooperation in Powell County. Clear communication, rapid response, and mutual aid prevented what could have been a catastrophic fuel and timber fire.

"Today could have turned out much worse," one responder noted.

"But everyone did their job, and the community should be proud of its fire departments and first responders."

Said property shall be sold to raise the amounts hereinafter set forth, together with interest and the costs of the action, and the following terms and conditions:

1. At the time of the sale, the successful bidder shall either pay cash or make a deposit of at least ten (10%) percent of the purchase price with the balance on credit for thirty (30) days. In the event of default by the purchaser the ten percent (10%) deposit made by the purchaser shall be applied to any costs and/or expenses of this action. In the event the successful bidder elects to credit the balance, he or she will be required to post bond and furnish an acceptable surety or sureties thereon. Said bond shall be for the unpaid purchase price and bear the interest rate of 6% per annum from the date of sale until paid. Any purchaser or purchasers shall have the privilege of paying said bond before maturity by paying the principal together with all accrued interest. Indictments were returned 12/18/25

This is a continuation from last week of the indictments returned on December 18. Because of the large number returned at once, they are being printed as space is available.

A person indicted remains innocent until proven guilty.

Jeffrey Berryman, 30, of N. Madison Ave., Irvine was the defendant in a four-count indictment.

Those charges include trafficking in a controlled substance, 1st degree, 1st offense (fentanyl) (enhanced), trafficking in a controlled substance, 1st degree, 1st offense (<2 grams methamphetamine) (enhanced), trafficking in a controlled substance, 1st degree, 1st offense (heroin), and trafficking in a controlled substance, 1st degree, 1st offense (fentanyl).

According to the indictment, on April 5, 2025, Berryman sold the fentanyl, and methamphetamine to a confidential informant while he possessed a 22 caliber revolver.

The weapon resulted in the first two charges listed as being enhanced. The enhanced penalty moves the charge up a class, meaning a larger sentence if convicted.

The indictment adds that Berryman sold heroin and fentanyl to a confidential informant on March 21, 2025.

Sgt. Campbell conducted the investigation.

Adam W. Allman, 47, of Richmond, Ky., was indicted for possession of a controlled substance, 1st degree, 1st offense (methamphetamine), possession of a controlled substance, 1st degree, 1st offense (drug unspecified), drug paraphernalia - buy/possess, controlled substance, prescription medine not in original container, driving motor vehicle using hand-held mobile telephone, and reckless driving.

Allman was traffic-stopped on August 28, 2025 by Sgt. Campbell.

The indictment says that Allman was using a hand-held mobile telephone while driving and was reckless by swerving from the white to yellow line continuously.

It adds that Allman had in his possession methamphetamine, 7.5 Amphetamine tablets, a pipe, and 9 Amphetamine pills in a cylindrical container but not the original.
