

PUBLIC NOTICE

An ordinance amending the Harlan County budget for fiscal year 2026, to include unanticipated receipts in the Road Fund in the amount of \$300,000 and increasing expenditures in the Road Fund in the amount of \$750,000 was adopted by the Harlan County Fiscal Court on May 21, 2026.
