Railroaders' season ends in second round of OVL Playoffs

The Fulton Railroaders dropped game 3 of a best-of-3 series in the second round of the OVL Playoffs against Hoptown Hoppers, ending their 2026 season.

The Railroaders finished the season with a 14-29 record after sweeping the Full County Rhythm in the first round of the OVL Playoffs.

Despite a three-hit performance from Jacob Lott, the

Fulton Railroaders fell 10-2 to the Hoptown Hoppers Mon., July 27, after the game had to resumed in the top of the eighth inning after the game was suspended due to weather Sun., July 26.

Lott went 3-for-4 with a two-run home run in the sixth inning and singles in the first and eighth. Hoptown built a 3-0 lead in the third before adding five runs in the sixth to pull away.

Luca Dickinson took the

loss for Fulton, allowing eight runs (seven earned) on 11 hits over 5.1 innings. Heath Henley earned the win for Hoptown, giving up two runs (one earned) on five hits over six innings.

The Hoppers finished with 12 hits, led by Brennen Gibson's 3-for-5 effort, while Fulton turned one double play in the loss.

The Fulton Railroaders ral-

lied for a thrilling 15-14 walk-off victory over the Hoptown Hoppers Sat., July 25 at Lohaus Field, with Evan McCarthy blasting a two-run home run in the bottom of the ninth to cap the comeback.

Ben Kauffman led Fulton offensively, going 3-for-6 with five RBIs, including a grand slam in the sixth inning. Nick Causey, Thomas Kuhn and Kauffman each had three hits, while Caleb Warren added a two-run homer.

Freddie Londo earned the win in relief, tossing 1.2 hitless innings with three strikeouts. Grant Baskin started for Fulton, allowing seven runs (four earned) in 1.2 innings.

The Railroaders finished with 16 hits, while Hoptown collected 17. Brennen Gibson paced the Hoppers with three hits, including a two-run homer, as Hoptown stole seven bases in the loss.

The Fulton Railroaders dropped a 13-2 decision to the Hoptown Hoppers Fri., July 24 in Hopkinsville.

Hoptown scored two runs in the first inning and added four more in the second to take control early. Ozzy Ramirez took the loss for Fulton, allowing six runs on seven hits over two innings. Brady Davis pitched four innings in relief, striking out seven while surrendering seven runs.

Thomas Kuhn led the Railroaders at the plate, going 2-for-3, while Jacob Lott drove in a run. Fulton committed no errors, with Jeremiah Bowman recording seven defensive chances.

The Hoppers finished with 15 hits, led by Myles Denton, Evan Jacob and Brennen Gibson with three hits apiece. Denton also drove in three runs, while Joe King earned the win after allowing two runs over six innings with eight strikeouts.

Chase Cameron, Wade Sabo and Jacob Lott each hit solo home runs, while Ben Kauffman went 3-for-4 with two RBIs. Sabo, Kauffman and Evan McCarthy drove in two runs apiece as Fulton totaled 10 hits.

Grant Baskin earned the win in relief, allowing one run on two hits over 4.2 innings with five strikeouts. Starter Michael Dobbins struck out six over 4.1 innings.

The Railroaders broke a 4-4 tie with three runs in the fifth inning and added insurance runs in the sixth and eighth to secure the victory and a berth in the OVL semifinals.
