are very good players for Grayson County. Logsdon scored 19 points to lead Grayson and Langdon had 12. Brody Armstrong had a double-double with 17 points and 11 rebounds. Armstrong was also tough defensively on Watkins.

Grayson County (19-6) is capable of a lot in what's left of this high school basketball season.

Daviness County (22-6) has proven how good it is, and now needs to look at how good it still can be.

"I didn't think we were very fluid offensively," DC coach Neil Hayden said Tuesday night. "They were intentionally trying to get us in the paint. We've got to figure out how to get more of a flow to try and get some other guys going."

Moss became more assertive in the fourth quarter, trying to keep Grayson from gaining control of the game.

"He was trying to keep us in the game," Hayden said.

Grayson played physical with Watkins.

"They pushed him off his spot, doubled him some," Hayden said of Watkins. "I thought he kind of floated a bunch tonight. He only got four shots, and we're not going to win games if he only shoots it four times. We've got to figure out how to get him more involved."

A late season matchup like this, between the two best teams in the region, will be

viewed as a measurement of what each team could do in the postseason.

That thinking didn't count for much last year. Grayson beat DC in a triple overtime game in Leitchfield on a last second shot.

Daviness County beat Grayson by 13 points in last year's regional championship game.

If all the rankings hold, Daviness County and Grayson County should meet in the 3rd Region championship game. Grayson won on Daviness' home floor in an energy-charged matchup. Will that be a wake up call for Daviness County?

"We'll find out," Hayden said. "Grayson is good. It is what we make of it. This

is the first time we've lost to anybody in the region. We'll dwell on this and get ready for district."
