

PLAINTIFFS were granted an Order of Sale on the above property in Metcalfe County Circuit Court Case No. 16-CI-00027 on November 25, 2025, due to the failure of Defendants to comply with Agreed Judgment entered on February 3, 2017. There is presently due, owing and payable by Defendants Daniel T. Shaw and Casey Shaw unto South Central Bank the principal sum of \$23,064.42, with accrued interest as of November 5, 2025, in the amount of \$11,495.74, plus late charges of \$199.51, fees of \$1,353.91, Mortgage Release Fee in the sum of \$46.00 dollars and interest accruing at the daily rate of \$8.53 from and after November 5, 2025. The property is being sold free and clear of any interest of Respondents.
