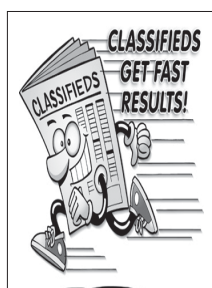

seeing regular varsity action. Cox, a catcher who can also play multiple positions, has provided consistency at the plate and helps turn the lineup. She has signed with Campbellsville University to continue her academic and bowling career.

Head Coach Deena Hurt, now in her third season, continues guiding a program that has been rebuilding since 2021. Key contributors include juniors Harper Hurt, Allie Herrington, and Aubrey Phelps, all three-year starters. Freshmen Emma Groce and LeeElla Boles have added production at the plate.

Pitching duties are led primarily by eighth-grader Rory Bragg, with additional support from Hurt. Power in the lineup comes from Boles and eighth-grader Camdyn Dubree.

The 16th District remains highly competitive. Russell County is again a district contender, while Cumberland County brings a veteran-heavy lineup with power. Clinton County continues to feature solid pitching, and Monroe County's return makes it a five-team district.

As a result, Metcalfe County is expected to play in a 4-5 seed matchup to advance in district tournament play, with the winner earning a chance to face the top seed.

"Our goal is to get out of that 4-5 game," Hurt said. "Our goal is to get to the championship game and back to the region tournament. It is something special for these girls to get to play on that WKU field, and I want them to experience that."
