#### ORDINANCE REQUIRING LARGE SCALE EVENT PERMIT AND PUBLIC SAFETY COORDINATION BY SUMMARY

Now comes the undersigned, an attorney licensed to practice in the Commonwealth of Kentucky, and certifies his preparation of the summary of the above titled ordinance, pursuant to KRS 83A.060 (4) & (9). The City of Stanford is passing an Ordinance for "large-scale" events, such being defined as any event that an organizer reasonably anticipates two hundred (200) or more participants. For such events, an organizer must apply for a permit from the Chief of Police, or his designee, and such authorized person shall issue a written authorization/permit, when he or she is satisfied that coordination, planning, and compliance with the ordinance has occurred. Applications for permits shall be filed thirty (30) days prior to such an event (unless waived by the authorized person). Any Event Organizer must meet with public officials, and address issues such as the expected attendance, layout, traffic flow, parking, pedestrian safety, proposed road closures, emergency ingress and egress, security, and sanitation and restroom issues. The authorized person may approve, modify or deny proposed closures. The Chief of Police may cancel road closures if necessary for public safety. The Chief of Police may modify or terminate road closures. Events excluded from this ordinance include those conducted by the City, County, school events, funeral processions, and religious activities. The Stanford Police are the office who shall be the primary coordinator of these requirements and procedures. Further, the undersigned sayeth, naught, but signs as having satisfied the statutory requirements for reading and publishing the foregoing Ordinance, by summary.
