To be discussed: **PUBLIC HEARING:** The Board of Commissioners will consider the request for a Conditional Use Permit for a home occupation for retail sales at 1655 Walnut School Road. The request is to conduct retail sale from the home owned by Darrel & Lois Horst for the local community.

NOTICE OF ADOPTION

Ashlee Cottrell is notified that a petition for adoption of a child, initialed CES, born to Ashlee Cottrell ("Ashlee") on January 1, 2013, was filed in the office of the clerk of Clark County Circuit Court, 501 East Court Avenue, Jeffersonville, Indiana 47130. The petition for adoption alleges that Ashlee's consent to the adoption of CES is not required due to her lack of involvement in this action and the child's life since she was a baby under Indiana Code ("IC") 31-19-9-8, and the fact that Ashlee has been non-compliant with any of the Indiana Department of Child Services Dispositional orders. If Ashlee Cottrell seeks to contest the adoption of the child, she must file a motion to contest the adoption in accordance with IC 31-19-10-1 in the above-named court not later than fifteen (15) days after the date of service of this notice.

If Ashlee Cottrell does not file a motion to contest the adoption within fifteen (15) days after service of this notice, the above-named court will hear and determine the petition for adoption. Ashlee's consent to the adoption of CES will be irrevocably implied, and she will lose the right to contest either the adoption or the validity of her implied consent to the adoption. No statement made to Ashlee Cottrell relieves her of the obligations under this notice.

This notice complies with IC 31-19-4.5-3 but does not exhaustively set forth a person's legal obligations under the Indiana adoption statutes. A person being served with this notice should consult the Indiana adoption statutes.

This Summary is prepared by John Hackley, an attorney practicing in the Commonwealth of Kentucky, and pursuant to KRS 83A.060(4) and (9), hereby summarizes the above referenced Ordinance, for reading and publication.

AN AMENDED ORDINANCE OF THE CITY OF STANFORD, KENTUCKY FIXING AND ESTABLISHING THE ANNUAL SALARY AND COMPENSATION FOR THE ELECTED OFFICE OF MAYOR OF THE CITY OF STANFORD AND FOR THE ELECTED OFFICE OF COUNCILPERSON OF THE CITY OF STANFORD FOR THE TERM OF OFFICE BEGINNING IN JANUARY OF 2024 [2027] AND COLA RETROACTIVE TO JANUARY OF 2020.

The City of Stanford is enacting an Amended Ordinance increasing the salary of the next elected Mayor to Forty-Five Thousand (\$45,000.00) Dollars, and retaining the current salary of council persons, while retaining the COLA increase based upon annual cost-of-living reporting by the Governor's Office of Local Government.
