

Ashlee Cottrell is notified that a petition for adoption of a child, initiated CES, born to Ashlee Cottrell ("Ashlee") on January 1, 2013, was filed in the office of the clerk of Clark County Circuit Court, 501 East Court Avenue, Jeffersonville, Indiana 47130. The petition for adoption alleges that Ashlee's consent to the adoption of CES is not required due to her lack of involvement in this action and the child's life since she was a baby under Indiana Code ("IC") 31-19-9-8, and the fact that Ashlee has been non-compliant with any of the Indiana Department of Child Services Dispositional orders. If Ashlee Cottrell seeks to contest the adoption of the child, she must file a motion to contest the adoption in accordance with IC 31-19-10-1 in the above-named court not later than fifteen (15) days after the date of service of this notice.
