Bellerive asks city commission to push back payment:

The Nicholasville City Commission considered a request from Bellerive Development to postpone a \$100,000 payment owed to the city in 2009 and delay it until 2012.

Three projects added to state road plan:

Three Jessamine County projects were included in the state's six-year road plan during the legislative session, including planning phases for the Eastern Bypass and the Interstate 75 corridor.

Purebred passion continues:

Though lacking glamour, caring for neglected horses remained a passion for the Hunter family, who owned several horses and managed a 72-acre equine rescue center.

Wilmore voices concerns over easement variance:

On March 9, the Wilmore City Council directed City Attorney Bobby Gulette to draft a letter to the Jessamine County-City Board of Adjustments expressing disapproval of a proposal involving a variance to Wilmore's 200-foot easement ordinance. The board was scheduled to hear the request March 19.
