ORDINANCE NO. 2026-06

AN ORDINANCE ADOPTING THE CITY OF CALVERT CITY, KENTUCKY ANNUAL BUDGET FOR THE FISCAL YEAR JULY 01, 2026 THROUGH JUNE 30, 2027 BY ESTIMATING REVENUES AND RESOURCES AND APPROPRIATING FUNDS FOR THE OPERATION OF CITY GOVERNMENT

WHEREAS the City Council of the City of Calvert City, Kentucky has reviewed the budget proposal of the Mayor and has developed a budget for the fiscal year beginning July 01, 2026 and ending June 30, 2027, in anticipation of the financial needs of the City; and,

WHEREAS the City Council of the City of Calvert City, Kentucky has reviewed and approved the proposed budget of the Board of Public Utilities for the City's municipal water and sewer system.
