**NOTICE OF BOND RELEASE**

In accordance with KRS 350.093, notice is hereby given that CCU Coal and Construction, LLC, 544 Chestnut Street, P.O. Box 1027, Coshoc-ton, Ohio 43812, has applied for Phases I, II, and III bond releases on Increment 22 of Permit No. 889-0165, which was last issued on 8 September 2025 (Permit No. 889-0165 Renewal #3). The application covers a total area of 6.3 acres, located approximately 0.33 mile southeast of Central City in Muhlenberg County.

The permit area is located approximately 0.67 mile east of the U.S. 431 intersection with KY 2107 and located 1.25 miles northwest of Pond Creek.

The bond in effect for Increment 22 is Cash Bond #201343 in the amount of \$75,000. Its entire amount is requested for release.

For the Phases I-II-III release on this increment, the following steps have been completed (the increment entails an approved permanent access road): There has been successful completion of all surface coal mining and reclamation operations in accordance with the approved reclamation plan, such that the land is capable of supporting the approved postmining land use (pastureland). All reclamation requirements were completed in February 2026.

Written comments, objections, and requests for a public hearing or informal conference must be filed with the Director, Division of Mine Reclamation and Enforcement, 300 Sower Boulevard, Frankfort, Kentucky 40601, by Friday, 24 April 2026.

A public hearing on the application has been scheduled for Tuesday, 28 April 2026 at 9:00 A.M. at the Kentucky Department for Natural Resources (KDNr), Division of Mine Reclamation and Enforcement, Madisonville Regional Office, 625 Hospital Drive, Madisonville, Kentucky 42431. The hearing will be cancelled if no request for a hearing or informal conference is received by Friday, 24 April 2026.
