

# Fontana Italy's most decorated Olympian

## MILAN

Arianna Fontana became her country's most decorated Olympian when she led Italy to silver in the women's 3,000 meters short track relay at the Winter Games on Wednesday.

It was the 14th Olympic medal of Fontana's career,

eclipsing the record of fencer Edoardo Mangiagalli who won 13 medals between 1936 and 1960.

South Korea took gold and Canada bronze. It was the first short track gold of the Games for the Koreans, the most successful nation in the discipline at the Olympics.

Italian Prime Minister Giorgia Meloni was in the Milano Ice Skating Arena to witness Fontana make

## history.

The way was cleared for Italy to take a medal when a Dutch skater fell midway through the race, effectively turning it into a three-team contest.

Fontana, 35, has now won three medals at the Milan Cortina Games. She made her Olympic debut as a teenager when Italy hosted the Turin Games in 2006, picking up the first medal of her career in the

## women's relay.

She had the honor of carrying the Italian flag at the Opening Ceremony in the San Siro stadium this month but her relations with teammates and sports officials have been tense at times.

## TENSE RELATIONSHIP

In 2019, Fontana accused two teammates of deliberately causing her to fall during a training ses-

sion. The skaters were cleared after a lengthy disciplinary process.

She hinted she might switch allegiance to the United States in 2023 after a breakdown in relations with her national federation.

Fontana had missed out on her first chance to break the record on Monday, finishing fourth in the women's 1000 meters, race, after being barged by Chinese rival Gong Li during the final.

After that race she said she had a "bitter taste in her mouth," adding, that

she would not allow the quest for the 14th medal to distract her.

"I'll try to turn this anger into extra fuel to add to the fire," she said.

Fontana comes from the small town of Berbenno, around two hours' drive north of Milan, where the local bars are papered with signed photos of her.

Married to her coach, the Italian-American former skater Anthony Lobello, she speaks fluent English and has spent long periods training abroad.

# Switzerland wins first gold in ski mountaineering

Switzerland's Marianne Fatton clinched the first ski mountaineering gold medal in Olympics history

Thursday, winning by 2.38 seconds in Bormio, Italy.

France's Emily Harrop and Spain's Ana Alonso Rodriguez earned the first silver and bronze medals in the sport, which was approved in 2022 for addi-

tion to this year's Winter Olympics.

Harrop clocked a 2:59.77 on the 725-meter course, which included a 65-meter climb, a mid-point transition zone and speedy slalom descent to the

finish line at Stelvio Ski Centre.

Harrop clocked a 3:02.15, finishing nearly eight seconds faster than Alonso Rodriguez. Germany's Tatjana Paller placed fourth, ahead of Italian Giulia Murada and France's Margot Ravinel.

Anna Gibson, the lone American competitor, failed to advance past the semifinals.

Spain's Oriol Cadrona Coll won the first men's ski mountaineering gold medal. His time of 2:34.03 was just 1.52 seconds ahead of second-place Nikita Filippov, a neutral athlete from Russia.

France's Thibault Anselmet clocked a 2:36.34 to earn a bronze medal.

Cameron Smith, a 13-time national champion and lone American competitor in the men's field, failed to advance to the final.

The first ski mountaineering mixed relay at the Olympic level will be held at 7:30 a.m. ET Saturday in Bormio. Coverage from the Stelvio Ski Centre will air on USA Network.

Gibson and Smith will team up for that competition.

**Changing:** I do see why the walk-away option is tempting.

But you have experienced difficult, dramatic emotional growth in recent years, so it makes sense that it would knock such a relationship off-balance.

You're changing but your friend is not.

And why should she change, really? You don't like this side of her now that you see it through different eyes. To her, however, this tectonic shift is merely Friday. Her crime against you is to be who she has always been.

I am playing devil's advocate here; of course you want some willingness to listen. And your being explicit about your needs is an important step — especially for friends long accustomed to providing something else.

But asking for something does not create an obligation in others to provide it, not even best friends. And in this case it does seem to touch more on who she is than what she does. That she can't or won't pivot from issuing directives to head-pats is not the same as her choosing to cause you intentional harm — any more than it ever was. It's being set in her ways.

It is your prerogative to decide you're through with ways that upset you. Full stop.

If you want more time to reorient your new self to an old friend, though, and feel you owe your history that, then that's valid, too.


