THE OPPORTUNITY TO OBJECT ENDS 45 DAYS FOLLOWING THE DATE OF PUBLICATION OF THE LEGAL NOTICE IN THE MCCREARY JOURNAL (FORMERLY KNOWN AS THE MCCREARY COUNTY VOICE). THE PUBLICATION DATE OF THE LEGAL NOTICE IN THE NEWSPAPER OF RECORD IS THE EXCLUSIVE MEANS FOR CALCULATING THE TIME TO FILE AN OBJECTION, AND THAT THOSE WISHING TO OBJECT SHOULD NOT RELY UPON DATES OR TIMEFRAME INFORMATION PROVIDED BY ANY OTHER SOURCE. IT IS THE OBJECTOR'S RESPONSIBILITY TO ENSURE TIMELY FILING OF A WRITTEN OBJECTION WITH THE REVIEWING OFFICER.
