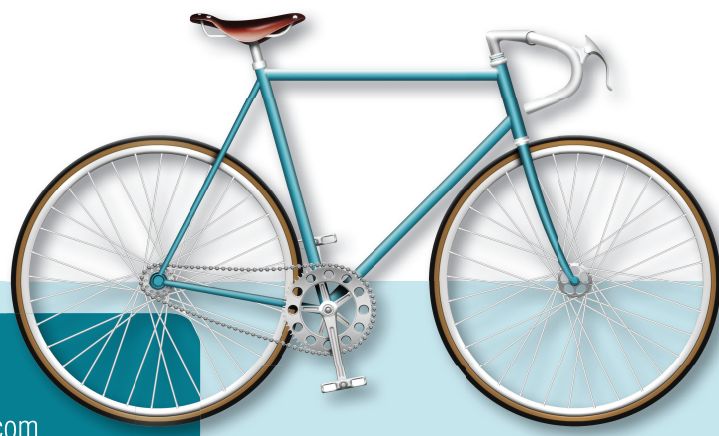

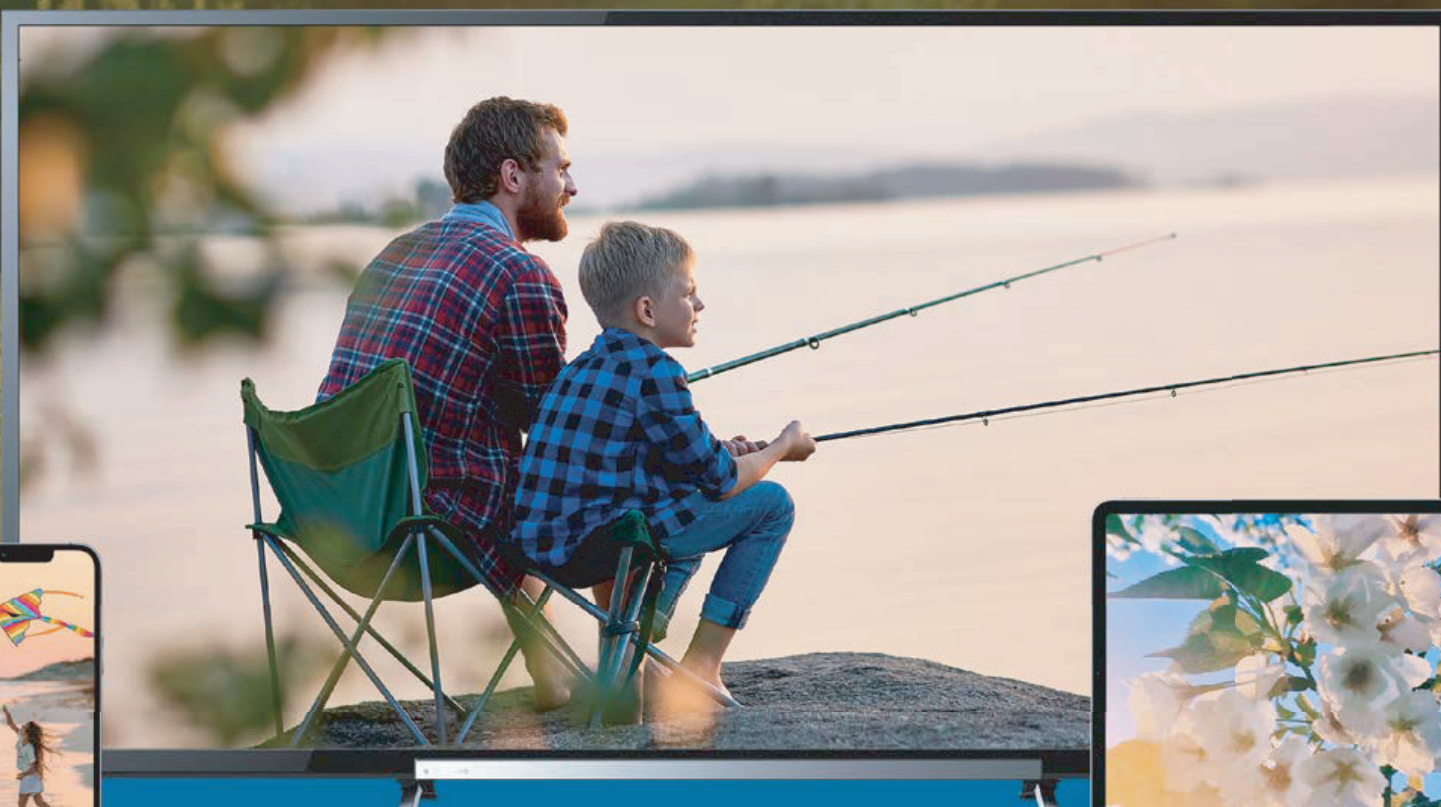

- In accordance with KRS 350.055, notice is hereby given that Cardinal Energy Group LLC 6800 Sherwood Drive, Knoxville, Tennessee 37919, has applied for a permit for an underground coal mining operation located 1.97 miles North-Northeast of Blackmont in Bell County. The proposed operation will disturb 12.66 surface acres within the permit boundary.
- The proposed operation is approximately 1.81 miles North-Northeast from Ky. 72 junction with U.S. 119 and 0.02 tenths of a mile south of Cardinal Branch. The latitude is 36-47-59 N. The longitude is 83-30-34 W.
- The proposed operation is located on the Balkan, and Wallins Creek U.S.G.S. 7 1/2 minute quadrangle maps. The surface to be disturbed is owned by Cardinal Energy Company LLC and Evans Coal Corp.
- The application has been filed for public inspection at the Department for Natural Resources Middlesboro Regional Office; 1804 East Cumberland Avenue; Middlesboro, Kentucky 40965. Written comments, objections, or request for a permit conference must be filed with the Director, Division of Mine Permits; 300 Sower Blvd, Frankfort, Kentucky 40601.
