**AN ORDINANCE OF THE
CITY OF
MIDDLESBOROUGH,
KENTUCKY, ESTABLISHING
THE AD VALOREM TAX LEVY
ON PERSONAL PROPERTY
FOR YEAR 2027**

WHEREAS, in accordance with
the provisions of Kentucky
Revised Statutes the
Middlesborough City Council
deems enactment of the
following ordinance to be in the
best interest of the City of
Middlesborough, and;
WHEREAS, enactment of this
ordinance is essential to ensure
that sufficient funds are
available to satisfy the
budgetary requirements of the
City.

NOW, THEREFORE, BE IT
ORDAINED by the Common
Council of the City of
Middlesborough, Kentucky as
follows:

Section One: On every
\$100.00 in value of all personal
property subject to taxation by
said City for the year beginning
January 1, 2027 and ending
December 31, 2027 assessed
for the said year by the Bell
County Property Valuation
Administrator for the said City
as of January 1, 2026 by the
Kentucky Railroad
Commission, by the State
Board of Valuations, and by any
other assessing authorities, and
by the Statutes of Kentucky,
there is hereby levied and
ordered an ad valorem tax at the
rate of 23.20 cents on each
\$100.00 of assessed valuation
for the following purposes and
in the specified amounts as
follows:

The sum of 23.20 cents is
hereby levied on each \$100.00
of assessed valuation of
personal property subject to tax
for City purposes of defraying
the necessary expenses for
general operation of the City
Government and services in the
City of Middlesborough,
including payment of salaries
and all operating expenses of
the Police and Fire
Departments, Clerk, Collector,
Assessor, City Attorney,
Treasurer, Mayor and
Councilmen, and all other
employees of the City, and for
supplies and equipment for all
departments, traveling
expenses, and for all general
operating expenses of every
nature; and for the purposes of
paying all general expenses of
maintenance and repair of all
City property, including street
and rights-of-way, paying for all
utility services used by the City;
and for the purposes of
expansion of airport facilities,
buying rights-of-way, damages,
court costs, and to purchase
new pieces of equipment for
use in any of the various
departments of the City such as
fire, police, or street
departments, and for any and all
general purposes for which

such tax levy may be needed in
the general operation of the City
of Middlesborough.

The overall tax on personal
property of 23.20 cents is
distributed as follows:

General Fund 23 .20

Section Two: This Ordinance
shall become effective
immediately upon passage and
publication:

THE AD VALOREM TAX LEVY
FOR YEAR 2026**

WHEREAS, in accordance with
provisions of Kentucky Revised
Statutes, the Middlesborough
City Council deems enactment
of the following ordinance to be
in the best interest of the City of
Middlesborough and to be
essential to ensure that
sufficient funds are available to
satisfy the budgetary
requirements of the City.

NOW, THEREFORE, BE IT
ORDAINED, by the Common
Council of Middlesborough,
Kentucky, as follows:

Section One: On every \$100.00
in value of all real property
subject to taxation by said City
of the fiscal year beginning July
1, 2026and ending June 30,
2027 assessed for the said year
by the Bell County Property
Valuation Administrator for the
said City as of January 1, 2026,
by the Kentucky Railroad
Commission, by the State Board
of Valuations, and by any other
assessing authorities, and by
the Statutes of Kentucky, there
is hereby levied and ordered an
ad valorem tax at the rate of
6.90 cents on each \$100.00 of
assessed valuation for the
following purposes and in the
specified amounts as follows:

The sum of 6.90 cents is hereby
levied on each \$100.00 of
assessed valuation of real
property subject to tax for City
purposes of defraying the
necessary expenses for general
operation of the City
government and services in the
City of Middlesborough,
including payment of salaries
and all operating expenses of
the Police and Fire
Departments, Clerk, Collector,
Assessor, City Attorney,

Treasurer, Mayor and
Councilmen, and all other
employees of the City, and for
supplies and equipment for all
departments, traveling
expenses, and for all general
purposes of paying all general
expenses of maintenance and
repair of all City property,
including streets and rights-of-
way, paying for all utility services
used by the City; and for the
purposes of expansion of airport
facilities, buying rights-of-way,
damages, court costs, and to
purchase new pieces of
equipment for use in any of the
various departments of the City,
such as Fire, Police, or Street
Department, and for any and all
general purposes for which such
tax levy may be needed in the
general operation of the City of
Middlesborough.

The overall tax on real property
of 6.90 cents is distributed as
follows:

General Fund 6.90
Section Two: There has also
been imposed a bank franchise
and local deposit tax for year
2026 at a rate of 0.025% said
monies to be collected and paid
into the General Fund. Said
funds shall then be distributed
as follows:

General Fund 25.0

Section Three: A discount of 2%
will be allowed if the total bill is
paid through the month of
November, 2026.
Bills are net in the month of
December 2026.

Section Four: A penalty of 5%
shall be attached to the
collections of all taxes levied
and not paid before January,
2027.

Section Five: A penalty of 21%
shall be attached to the
collections of all taxes levied
and not paid before February,
2027.

Section Six: This ordinance shall
become effective upon
enactment and publication as
required by law.
