# Bardstown knocks off CHS at Holiday Classic

Fifth Region rival Bardstown kept Campbellsville from returning to the win column during the final round of the Taylor County Farm Bureau Holiday Classic, outlasting the Eagles 58-53 on Sunday, Dec. 28.

As a result of the loss, Campbellsville fell to 3-7 on the season.

Bardstown shot 42.2 percent from the field. The Tigers made two of 14 three-point field goal attempts and shot 75 percent from the free throw line.

Tylan Spalding led Bardstown to the win, scoring a game-high 19 points. Spalding connected on six of seven free throw attempts. Chi Poynter accompanied Spalding in double figures for Bardstown, netting 14 points.

Campbellsville shot 43.8 percent from the field. The Eagles made three of 13 three-point field goal attempts and hit 61.5 percent (eight-of-13) from the free throw line.

Keaton Hord paced Campbellsville, scoring 19 points. Ty

Milburn netted 13 points and Jalen Gribbins tallied 10 points.

Finishing in single digits, Cole Kessler (four points), Lanigan Price (four points), Rowan Petett (two points) and Ty Burwash (one point) accounted for the rest of the CHS scoring.

Nearly recording a double-double, Milburn claimed a game-high nine rebounds.
