ORDINANCE 2026-02
 AN ORDINANCE AMENDING THE CITY OF CARROLLTON ZONING MAP AND AMENDING CHAPTER 156 ZONING CODE, §156.002 TITLE, IN ORDER TO UPDATE THE MAP INCORPORATED INTO THE ZONING CODE

WHEREAS, the City Council of the City of Carrollton has found and determined that there needs to be a modification to the City of Carrollton Zoning Map, and same has been properly recommended by the City of Carrollton Planning and Zoning Commission; and

WHEREAS, the City Council of the City of Carrollton has found and determined that it is in the best interest of the citizens and residents of the City to amend and update the City of Carrollton Zoning Map,

NOW THEREFORE BE IT ORDAINED by the City Council, City of Carrollton, Commonwealth of Kentucky:

(1) That the current zoning map be and hereby is amended in accordance with the Recommendations of the City of Carrollton Planning and Zoning Commission on March 2, 2026, and November 3, 2025, which new revised map is attached hereto and incorporated herein by reference;

(2) That Chapter 156 Zoning Code, §156.002 Title be amended solely to update the zoning map incorporated therein so as to include the amendments made herein. The Ordinance section shall read as follows:

§ 156.002 TITLE.

(A) This chapter may also be known and cited as the city zoning code. The zoning map referred to herein is hereby made a part of this chapter by reference.

(B) Certified copies of this chapter are on file with the Planning Commission, with the Carrollton County Clerk, and with the City Clerk/Treasurer.

(3) That the Zoning Map and Chapter 156 Zoning Code, §156.002 Title may be waived, altered, or suspended only by a change of ordinance.

(4) This ordinance shall become effective after two readings and publication requirements have been met.

FREQUENTLY ASKED QUESTIONS

When is the last day to register to vote?
 April 20, 2026

- Online Registrations must be received by 4:00 PM Local Time;
- Mailed Registrations can be Postmarked 04/20/2026 and be counted.
- Registrations returned to the Clerk's Office will be accepted through Close of business 04/20/2026.

When will the Online Portal open?
 April 4, 2026

When will the Online Portal close?
 May 5, 2026 at 11:59 pm

You may use our drop box located in our office at 30 Hwy 42 East, Bedford, KY or return by mail. Remember this ballot is front and back. Vote both sides.

When is 6 day excuse absentee voting?
 Wednesday, 05/06/2026, Thursday, 05/07/2026, Friday, 05/08/2026, no voting on Saturday or Sunday, Monday, 05/11/2026, Tuesday, 05/12/2026, and Wednesday, 05/13/2026 during office hours.

When is the NO Excuse 3 day in-Person Voting?
 Thursday, 05/14/2026 9 AM until 5 PM and Friday 05/15/2026 10 AM until 7 PM and Saturday, 05/16/2026 8 AM until 4 PM. No voting on Monday, 05/18/2026.

How is the privacy of my mail-in or hand-delivered ballot protected?
 In short, once the voted ballot envelope has been received and checked back in at the Clerk's Office, the signature is verified as the voter's. The ballot will be separated from the envelopes by a ballot processing committee consisting of four Trimble County voters of each party. Once all the ballots have been separated from their envelopes, the ballots will be inserted into the scanner to be counted. This process prevents anyone from knowing how someone voted. This process has been open to the public in the past.

SEVERAL WAYS TO VOTE

Mail in (phone request)
 You can call our office at 502-255-7174 or 502-255-4913 to request a ballot. We will enter your information into the Portal and a ballot will be mailed to you. Once the voter receives their ballot, they will make their selections, place the ballot in the appropriate envelope, sign the tan and white envelopes on the highlighted areas, seal the envelope and mail it back or use our Drop Box located in the County Clerk's office. The deadline to apply for a mail-in ballot is 05/05/2026 at 11:59 PM.

Mail in (using the portal)
 Voters can use the online portal beginning 04/04/2026 to request an absentee ballot. Remember there are reasons that are required to be eligible for a ballot by mail. Here are the reasons:

1. A resident of Kentucky who is a covered voter as defined in KRS 117A.010;
2. A student who temporarily resides outside the county of his or her residence;
3. Incarcerated in jail and charged with a crime, but has not been convicted of the crime;
4. Changing or has changed his or her place of residence to a different state while the registration books are closed in the new state of residence before an election of electors for President and Vice President of the United States, in which case the voter shall be permitted to cast a mail-in absentee ballot for electors for President and Vice President of the United States only;
5. Temporarily residing outside the state but still eligible to vote in this state;
6. Prevented from voting in person at the polls on election day and from casting an excused or no-excuse in-person absentee ballot on all days in-person absentee voting is conducted because he or she will be absent from the county of his or her residence all hours and all days excused or no-excuse in person absentee voting is conducted;
7. A participant in the Secretary of State's crime victim address confidentiality protection program as authorized by KRS 14.312; or
8. Not able to appear at the polls on Election Day or the days excused or no-excuse in-person absentee voting is conducted on the account of age, disability or illness and who has not been declared mentally disabled by a court of competent jurisdiction.

Here is how it works:

Mail in Absentee

1. Complete a request form at govoteky.gov by 05/05/2026 at 11:59 PM.
2. Your absentee ballot will be mailed to you to mark at home. Put your voted ballot in the return envelope. Do not forget to sign both the white and yellow envelopes.
3. Mail or use our drop box to deliver your ballot back to us as soon as you can. It must be postmarked by Election Day, 05/19/2026.

If you do not have a computer, please call the County Clerk's office at 502-255-7174 or 502-255-4913 and we can process your request. Remember the cutoff to request a mail out ballot is 05/05/2026 at 11:59 PM.

Drop Box
 If you do not want to mail your ballot back to use, there will be a Ballot Drop Box in the County Clerk's office during business for you to insert your ballot envelope. You can use this Drop Box until Election day, 05/19/2026 at 6 PM.

In-Person Voting
When does 6 day Excuse based In-Person Voting begin and end?
 6 day Excuse based In-Person Absentee Voting begins 05/06/2026 through 05/13/2026 during regular business hours: Monday through Friday 8:30 a.m.- 4:30 p.m.. These are the eligible reason to request a ballot during this time.

Reasons for voting an Excused In-Person Absentee Ballot

1. Is a resident of Kentucky who is a covered voter as defined in KRS 117A.010, who will be absent from the county of his or her residence on the day of an election and during the days of no-excuse in-person absentee voting;
2. Has surgery, or whose spouse has surgery scheduled that will require hospitalization on the day of an election and during the days of no-excuse in-person absentee voting;
3. Temporarily resides outside the state, but is still eligible to vote in this state and will be absent from the county of his or her residence on the day of an election and during the days of no-excuse in-person absentee voting;
4. Is a resident of Kentucky who is a uniformed-service voter defined in KRS 117A.010 confined to a military base on election day and during the days of no-excuse in-person absentee voting;
5. Is in her last trimester of pregnancy and the voter completes the form that is prescribed by the State Board of Elections, which contains a sworn statement that the voter is in her last trimester of pregnancy at the time she wishes to vote;
6. Has not been declared mentally disabled by a court of competent jurisdiction and, due to age, disability or illness, is not able to appear at the polls on election day and during the days of no-excuse in-person absentee voting;
7. Is a student who temporarily resides outside the county of his or her residence and will be absent from the county of his or her residence on the day of an election and during the days of no-excuse in-person absentee voting;
8. Any person employed in an occupation that is scheduled to work during all days and all hours, which shall include commute time, the polls are open on election day and during the days of no-excuse in-person absentee voting; or
9. Any election officer tasked with election administration for the current election cycle.

6-day In-Person Excuse Voting
 Beginning Wednesday, 05/06/2026, eligible voters are able to vote In-Person at the Trimble County Courthouse, in the hall adjacent to the County Clerk's Office. Voters will need their photo ID. Voters will be checked in as normal. Voters will be directed to a table to mark their ballot. Once the ballot has been marked, the voter will be directed to a table to mark their ballot. Once the ballot has been marked, the voter will be directed to the scanner to insert your ballot. In-Person Excuse based voting starts Wednesday, 05/06/2026, Thursday, 05/07/2026, Friday, 05/08/2026, 8:30 a.m. - 4:30 p.m., Monday, 05/11/2026, Tuesday, 05/12/2026 and Wednesday, 05/13/2026, 8:30 a.m.-4:30 p.m.

3 Day No Excuse Voting
 No Excuse Voting begins Thursday, 05/14/2026 from 9 a.m. until 5 p.m. and Friday, 05/15/2026 from 10 a.m. - 7 p.m. and Saturday, 05/16/2026 8 a.m. - 4 p.m.. All voters will need their photo ID. This is early voting and there will be no excuse needed during these days of voting. Any Voter is eligible to vote during the 3 day No Excuse Voting unless you have already voted absentee. It will be held at the Trimble Courthouse, in the hall adjacent to the County Clerk's Office.

Ballot's will be logged and counted each day beginning 04/06/2026-05/19/2026 at 4:16 p.m. excluding Wednesday's.

Election Day
 Election Day is 05/19/2026 from 6 a.m. - 6 p.m. You will go to voting locations either Bedford Elementary School or Milton Elementary School. Please have your driver's license or photo ID out and ready to scan to help keep the lines moving.

Things to Keep in Mind
 The County's Election Plan is using vote centers, meaning you can vote at any location, Bedford or Milton. This should be quicker and easier for the voter. Remember your ID! If you have any questions, please call our office 502-255-7174.
