South Oldham 9U and 11U Little League Team win the state championships

The South Oldham Little League 11U and 9U All-Star Team won the Kentucky State Little League championship on July 22 and July 26, respectively. The 11U Team became the first 11U South Oldham Little League Teams to win a state championship. The 11U state tournament was from July 18-22. They went 2-1 during pool play. South Oldham lost its first game 5-4 against Lexington Eastern but bounced back with a 17-2 win over Washington

County and a dominant 20-0 shutout win over Ashland to earn a spot in the semifinals. South Oldham pitcher Easton Gum threw a complete-game shutout in the semifinals to help secure a 2-0 win over Bowling Green. In the finals, South earned its revenge against Lexington Eastern with a staggering 7-2 victory to claim the first Little League State Championship for the 11U South Oldham Little League Team. The 11U State Championship Team was made up

of Beckham Durham, Caleb Bach, Carter Bierman, Easton Gum, Grant Goodwin, Grayson Black, Lincoln Hoagland, Maddox McCoy, Mason Bickley, Mason Nichols, Palmer McKenzie and Sam Riddell. The team was coached by Kurt Riddell, Tyler McKenzie, Brandon Durham, Jeff Gum and James Hoagland. The 9U Little Team captured gold as well with a 5-1 win over Eastern Little League to give Oldham County four of six Little League State Championships in 2026.

varsity handle those big moments, so we're going to be practicing those," Pannell said.
