Manual repeated as the regional champions with 579 points. Male was a distant second with 278 points.

Bullitt East took the number three spot with 172 points. Central was fourth with 112 points. North Bullitt closed as the number five team with 63 points while Bullitt Central had 32 points.

As in the past, all three Bullitt County programs train together under a single head coach. The coach this season is Jeremy Ringo. The swimmers then swim in meets representing their own school. The teams practice once a week at the University of Louisville pool.

The sport could see some changes starting next season as the city of Shepherdsville will open a swimming facility.

The following results are sorted by the order that they were conducted live that day. The top two finishers in each event advanced automatically to the First Round of the State Tournament that was held this past weekend at the University of Louisville (see that story in this issue). Others from the regional could have advanced based on time.

The top eight finishers in each event earned 'team' points.
