quarter, North Bullitt was ahead 13-10. But the visitors would tie the score at 12 on a Cami Bickett three-pointer. The game would continue to swing back and forth. Bullitt Central would go into the locker room at 21-18 when Awel Deng got a rebound basket and Abrie Dillman hit one of two free throws. When Kynslee Gibson and Chloe Hurst hit back-to-back baskets, with Hurst's being from beyond the arc, the visitors seized a 26-18 lead. That's when North Bullitt began its comeback. Kylie Downing hit a couple of free throws and Nikkiah Campbell scored on a layup off a steal. Brynlee Eskridge hit a pair of free throws and Jayden Bauer hit a trey. Still, Bullitt Central led by three after Dillman drained a three-pointer. With Mahijah Fell coming back into the game playing

with three fouls, North Bullitt went on an 11-5 run to take the three-point lead going into the fourth quarter. During that span, Fell hit a pair of free throws and scored inside. The senior also picked up her fourth foul with 1:32 left in the period and went to the bench. In the final quarter, Bickett returned after missing a few minutes with an injury. Downey made a steal and hit two free throws to stretch the lead to five until Bickett scored on a drive. Deng's rebound bucket tied the game and Hurst's free throw but the Lady Cougars in front for the final time at 43-42 with 4:03 left to play. Fell hit one of two free throws to knot the score but a technical foul led to Downey's two charity tosses and a 45-43 lead with 2:39 left. With the ball in the senior's hands, Downey was fouled and hit another pair of free throws. Molly Johnson got an offensive rebound and basket to make it 47-43 with

2:09 to go. Campbell's rebound and free throw pushed the lead to five. The young Lady Eagles were not content to hold the ball. So a missed layup and a missed short shot gave the visitors new life. Bickett's long three-pointer with 43 seconds left cut the North Bullitt lead to 48-47. Another missed layup for the Lady Eagles turned out OK as North Bullitt got the rebound and Downey was fouled with 12 seconds left. She hit the second attempt to make it 49-47. But it would be Fell who intercepted the in-bounds pass and Downey's final two free throws salted away the 51-47 victory. Looking at the stat book, the North Bullitt head coach could only grimace. His team shot just 11 of 51 from the field for a chilly 21 percent. But the Lady Eagles made up for that by hitting 26 of 38 from the charity line. In the second half, Downey felt the players did a good job of applying more pressure

on the defensive end. And he said they did a better job of keeping Bickett in their sights. Much of the defensive assignment on Bickett fell on the shoulders of sophomore Molly Johnson. "She just works hard and she does what we need for her to do," Downey said of Johnson. At the end of the game, Downey said he doesn't want his players to not shoot open shots. But, at the same time, they must also get the ball into the hands of the good free throw shooters. "We did the small things tonight," said Downey, whose team is now 3-0 in district play. If the team doesn't rebound or play good defense, he said it is difficult for the Lady Eagles to win. Of course, when they do have those occasion evenings when the shots are falling, he said they can play with anyone in the region. "I hope we build on this win," said Downey. "It's a good win against a quality oppo-

nent." Despite hitting just one of 17 from the field, Kylie Downey led the Lady Eagles with 15 points, hitting 13 of 14 from the foul line. Nikkiah Campbell added 11 points. Johnson led the winners with eight rebounds. For Stephanie Still Troutman, the Lady Cougar coach remembers those Bullitt Central-North Bullitt battles. Prior to the game, she said the coaches had put in some new offensive plays and she was pleased with the execution. In the first half, Troutman was pleased with the defensive effort and the communication between the players. After intermission, she felt things were pretty physical and North Bullitt did a good job of getting to the foul line. With a tough atmosphere and facing pressure defense from the host, Troutman was pleased the way her team responded. "We'll take a lot of good things from tonight," said

Troutman, whose team will be the third seed and will serve as host of the District 23 tournament later this month. The Lady Cougars shot only 30.8 percent from the field and 43.8 percent from the foul line. Bickett was the lone Lady Cougar in double figures with 21 points. Deng led Bullitt Central with 11 rebounds. There is a possibility that the two teams could in fact face one another in the post-season. by a Manual swimmer was 1:00.63. **100-yard Freestyle** – Bullitt East picked up team points from a pair of strong finishes in this race. Bischoff had a strong swim and placed fifth in 1:10.72 while Payton Jones, a junior, finished seventh in a time of 1:14.07. The winning time by a Manual swimmer was 56.75. **500-yard Freestyle** – The longest event of the meet had only three starters and only two finished. Male won the event in 5:56.80 while Bullitt East 8th-grader Abigail Davis finished second in 6:04.26. **200-yard Freestyle Relay** – North Bullitt was one of three teams in this event that started but only Manual finished. North Bullitt had an early take off on the final exchange and was disqualified. The Lady Eagle

team included junior Taryn Snook, freshmen Ava Wooden and Brianna Bell along with 8th-grader Ally Hubbard. **100-yard Backstroke** – Taryn Snook picked up team points for North Bullitt as she finished eighth in this event in a time of 1:40.67. Manual had the top four finishers in this event including the winning time of 1:04.62. **100-yard Breaststroke** – The only Bullitt County win of this meet came in the last individual event of the day when Bullitt East senior Makenzie Lovett led from the start and won the event with a time of 1:08.82. The runner-up time, by a Male swimmer had a time of 1:11.27. Bullitt East also got team points from 8th-grader Abigail Davis who finished fifth in a time of 1:20.25. **400-yard Freestyle Relay** – The Bullitt East team of Lovett, Jones, Davis and Bischoff finished as the

runner-up to Manual in the final event of the day. Manual won in a time of 4:01.03 while Bullitt East was second in a time of 4:34.22. North Bullitt finished third in this event with a time of 5:44.68. The team included Snook, Bell, Wooden and Hubbard, the same group from the 200-yard freestyle relay. **BOYS 200-yard Medley Relay** – Bullitt East had a good finish in this race as the Chargers finished third behind St. Xavier and Manual. The Chargers' team of senior Isaac Lewis, junior Myles Broskey, freshman Beau Ringo and 7th-grader Brody Ringo finished in a time of 1:59.31. St. Xavier won the race in 1:59.31. **200-yard Freestyle** – Brody Ringo, two years younger than any other swimmer in the race, had a

nice showing as the 7th-grader finished sixth in a time of 2:09.80. The winning time by a St. Xavier senior was 1:42.21. **200-yard Individual Medley** – No Bullitt County swimmer competed in this event. **50-yard Freestyle** – Bullitt East got points from two swimmers in this race. Isaac Lewis, a senior, finished seventh in a time of 25.40 while freshman teammate Beau Ringo finished eighth in 25.49. The winning time was 21.34 by a swimmer from Manual, one of 'only two boys' races that St. Xavier did not win. Lewis, who reached the Kentucky State Golf Tournament in October, will attend Centre to play golf. This race also had Bullitt East junior Myles Broskey, a junior, finish 12th in 27.64 while North Bullitt junior Brayton Terhune was 13th in 28.65. Bullitt East freshman Brayden Reese was 16th in

32.15. **100-yard Butterfly** – No Bullitt County swimmer competed in this race. **100-yard Freestyle** – The top finisher from Bullitt County was Bullitt East's Broskey in a time of 1:04.64 to finish tenth overall. Bullitt East 8th-grader Miles Lewis was 11th with a time of 1:06.65 while the Chargers' Reese was 14th in 1:16.23. **500-yard Freestyle** – Bullitt East got points from the younger Ringo brother as Brody Ringo finished seventh in the longest event of the meet. Ringo had a time of 5:53.00. **200-yard Freestyle Relay** – No Bullitt County team had an entry in this race. **100-yard Backstroke** – Bullitt East got points in this race as Beau

Ringo finished seventh with a time of 1:05.82. **100-yard Breaststroke** – Bullitt East was just out of the team points in this event as Isaac Lewis finished ninth in a time of 1:12.81. North Bullitt's Brayton Terhune was 11th in 1:15.90 while Bullitt East 8th-grader Miles Lewis was 13th with a time of 1:30.13. **400-yard Freestyle Relay** – It was a brother-brother act for Bullitt East in the final event of the day as the Chargers finished third in the long relay.
