

Lady Chargers get back into action with split

WASHINGTON – After not playing a game for a full two weeks, the Bullitt East Lady Chargers managed to get back in action on Friday, splitting a pair of games over the weekend.

Unlike some teams that pack the schedule with games

over the final weeks of the regular season, Bullitt East head coach Chris Stallings is standing pat with his schedule over the last two weeks of the regular season. The Lady Chargers have a huge game on Friday of this week against North Bullitt with the winner claiming the top seed for the upcoming 23rd District Tournament that will start the week of Feb. 22 at

Bullitt Central.

Bullitt East finally got into action on Friday with a game at home against Danville Christian. The Lady Chargers had no trouble in this one, rolling to a 73-41 victory.

Danville Christian, from the 12th Region, dropped to 14-8 with the loss as the team is fourth in its region in the RPI.

Stallings' team was just

under the 50 percent mark in this game and the squad made five of 15 attempts from outside the arc.

Leading Bullitt East in this game was senior Anna Timelli, who had 20 points. Charley Petrowski collected 10 points in the win while senior Mollie Johnson finished with nine points and 10 rebounds.

Lyla Packer finished with 11 rebounds.


