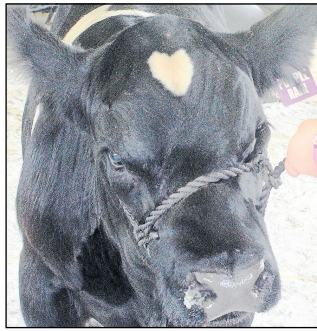

AN ORDINANCE AMENDING ORDINANCE 021-034 OF THE CITY OF SHEPHERDSVILLE RELATED TO ADOPTING A POLICY AND PROCEDURE MANUAL FOR NON-ELECTED AND APPOINTED EMPLOYEES OF THE CITY OF SHEPHERDSVILLE RELATING TO EMPLOYMENT MATTERS OF JOB CLASSIFICATION, HIRING, PROMOTION, DISCIPLINE, AND OTHER EMPLOYMENT ISSUES.

### SUMMARY

SECTION ONE: Sets forth that Ordinance 021-034 is amended as set forth herein.  
SECTION TWO: Sets forth that Section 7 related to health, retirement, and other benefits is amended to provide that the City may provide health, dental, and vision coverage for employees and their dependents up to a maximum amount as determined by the City and reflected in the annual budget.  
SECTION THREE: Sets forth the severability clause.  
SECTION FOUR: Sets forth the repeal of prior ordinances in conflict with this ordinance.  
SECTION FIVE: Sets forth the publication requirement.
