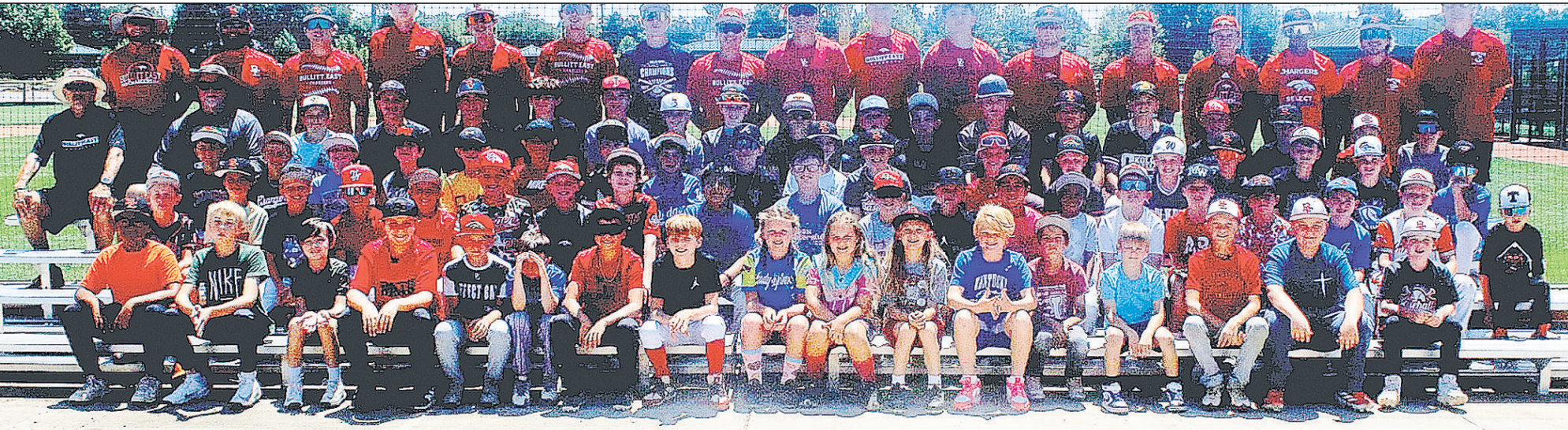

Purchase and installation of sun shades for City Pavilion

Washington is seeking sealed bids for the purchase and installation of twenty-five (25) new manually controlled retractable solar screens for the City Plaza Pavilion located at 300 Snapp Street, Mt. Washington, KY 40047. The bidder must visit the site and ensure that proper measurements are taken. Solar screens are requested to match the existing color (or be as close as possible). In addition to the installation, the bidder will be required to remove and dispose of the existing solar screens.
