

New candidate filings include magistrate race and U.S. Senate bids

LONDON — Several additional candidates have officially filed to seek public office ahead of upcoming elections, according to recent filings released by the Laurel County Clerk's Office and a separate announcement at the state level.

At the county level, Republican Tonya Poindexter has filed to run for Magistrate District 1, officially submitting her candidacy on Jan. 5. Poindexter joins Jason Neal Ivey and John Crawford in the district's primary race.

Chris Hubbard filed on Dec. 29 to run for Laurel County Surveyor as a Republican, adding a new race to the local ballot for the May 19, 2026 primary election.

At the federal level, Amy McGrath has officially filed with the Kentucky Secretary of State's to run for United States Senate, formally launching her campaign in Kentucky. McGrath, a former Marine Corps fighter pilot and previous Democratic nominee for statewide office, filed for candidacy on Tuesday.

Another new candidate vying for the Democratic nomination in the Senate race is Vincent Anthony Thompson, while Valerie "Dr Val" Fredrick of Murray filed in the race as a Republican.

Candidate filings for the 2026 primary election in London remain open through 4 p.m. this Friday at the Laurel County Clerk's Office, located inside the Laurel County Courthouse in London.

FEMA provided \$106 million to Kentucky disaster survivors in 2025

FRANKFORT, Ky. (KT) — The Federal Emergency Management Agency (FEMA) says they have now distributed more than \$106 million to survivors of the three federally declared natural disasters in Kentucky this year.

As of Oct. 20, FEMA has paid out \$67.9 million for losses suffered in February's severe weather, \$34.9 million for April's severe weather and record flooding, and \$3.7 million due to damage from May's tornadoes. While the deadline for apply for benefits in all three disasters has passed, FEMA continues to process applications and issue payments daily.

Kentucky Emergency Management (KYEM), along with FEMA Individual Assistance Specialists in Kentucky are continuing to answer survivors' calls at the state's Unmet Needs Call Center, which is (502) 607-6665.

Kentucky survivors who have already applied for federal assistance may call experienced agents at that number to request a case review, make an appointment to meet in person, check the status of appeals or confirm processing decisions, confirm whether submitted documents have been received, get answers to questions about information or documents needed to resolve ineligibility.
