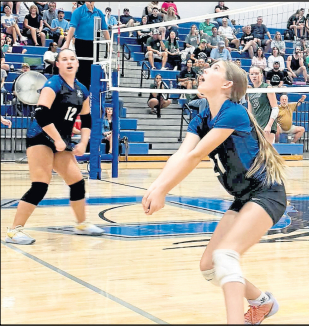
The Spencer County Middle School Lady Grizzlies Volleyball finished out their regular season play on Sept. 17 vs. South Oldham Middle School.

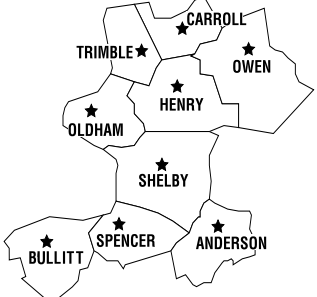
