down according to the Sheriff's Department. The third dog was located at a later time and confiscated.

Within minutes Sheriff Dale Ford received a call that the owner of the dogs resided at a residence on West Main Street in Gamaliel.

Deputy Austin Cook attempted to contact the residents of the home and after several minutes, Dawson A. Groce, 24, came outside.

At first, Cooke noted, he denied that he

was the owner of the dogs, but later admitted they were his.

Groce was then cited for two counts of harboring a vicious animal with further charges pending and a court appearance on Jan. 6, with Jacob M. Warren, 27, also being cited on the same charges.

The dogs that were killed were turned over to Jason Holland with the Monroe County Health Department to be tested this week


By press time,

the youth had been released from the hospital but was recuperating at home, with several bite marks and lacerations even down to the bone.

No update was available on the lady who was injured in the first attack.

However, the attacks are not a surprise to many of the neighbors in Gamaliel. These animals, they point out, have been reported multiple times, to several agencies, but nothing

was done about the issue.




