

Former UK swim coach settles sex abuse case filed by athletes

Two former University of Kentucky swimmers have settled their sexual harassment and sexual assault lawsuit against their former coach, Lars Jorgensen, on undisclosed terms.

Briggs Alexander and “Jane Doe” settled their claims against Jorgensen last week in U.S. District Court in Lexington in a brief agreement signed by

Judge Karen Caldwell. Their claims against the University of Kentucky and its former athletics director,

Mitch Barnhart, remain active and scheduled for trial in May 2027. Attorneys for Alexander,

Doe and Jorgensen did not respond to requests for comment.

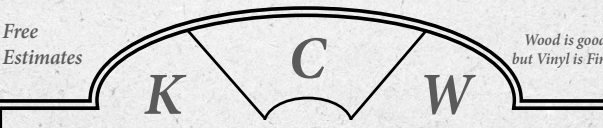
