reached the point where he could beat his brother, he began testing his skills against other players at Family Billiards in Owenton. After achieving success locally he branched out even further.

"I tried to win money wherever I went, so my circle just kept getting bigger and bigger," he said.

By age 17, Brumback was entering tournaments in bars across Carroll and Grant counties. He initially competed in 8-ball events before discovering the discipline that would define his career: bank pool.

In bank pool, every shot must be banked off a rail and the

player must call the shot beforehand. The game demands precision, creativity and a deep understanding of angles.

Brumback traces his introduction to bank pool to a regular trip he made to Lexington in his younger years.

"There was this old gentleman and I would play him 9-ball," Brumback said. "I'd beat him out of a couple hundred dollars."

After losing at 9-ball, the older player would convince Brumback to switch to bank pool, where he would promptly win his money back. "I didn't even like that game," Brumback recalled.

After the same scenario played out several times, he decided it was time to improve his bank pool skills. Once he mastered the game and began

defeating the older player at both 9-ball and bank pool, the matches came to an end.

"He quit playing me," Brumback said. "I just kind of had a knack for it, and I fell in love with it."

For Brumback, bank pool offers the ultimate challenge. "It takes the most amount of knowledge and the least amount of luck," he said.

Brumback was in his 20s when his bank pool career truly took off. He traveled to tournaments in Chicago, Washington, Louisville and Cincinnati, gaining valuable experience against some of the country's top players.

His first major tournament in Chicago didn't result in a victory, but it proved to be a turning point. "I didn't win, but I learned a lot," he said.

The lessons paid off for John who said, "I won every single bank tournament that I played in for like the next 20 or 25 years."

Over the course of his career, Brumback built one of the most impressive résumés in the sport. His accomplishments include the 2006 BCA Banks Championship, the 2007 U.S. Open Banks Championship, Derby City Classic Banks Championships in 2009 and 2010, and the 2009 Derby City Classic Master of the Table title.

After being named the greatest bank pool player in American history by The Best In Billiards, Brumback recently received additional recognition when Gov. Andy Beshear named him to Team Kentucky All-Star.

The honor came as a surprise

to his son, Patrick, who works in the Beshear administration and was unaware the recognition was coming until it was announced during a press conference.

Away from the tournament spotlight, Brumback enjoys a quieter life with his wife, Valerie, a retired teacher.

These days, local players often gather at the billiards room of Brumback's longtime friend, Greg Estes. Whether he's spending time with friends or quietly sharpening his skills, Brumback remains devoted to the game that first captured his imagination decades ago.

What began as a young boy's determination to beat his older brother ultimately grew into a legendary career that has left an ever lasting mark on the sport of pool.
