Forest Serv. waives recreation fees for King holiday

WINCHESTER, Ky., Janu-
 ary 13—The U.S. Department
 of Agriculture's Forest Service
 will waive fees at all Forest-
 operated recreation sites in the
 Daniel Boone National Forest
 on Monday, January 19, 2026,
 in honor of Martin Luther King
 Jr. Day. This waiver does not
 apply to recreation sites operat-
 ed by concessionaires, reserved
 group-use areas or recreation
 sites that have been closed for
 the season or maintenance.
