Snakebite victim rescued in Gorge, warning issued

Powell County Search and Rescue issued a warning this week to hikers in the Red River Gorge following the nighttime rescue of a snakebite victim.

The hiker in the Gorge was bitten by a copperhead around 1:00 a.m. Saturday. Powell County Search and Rescue and Powell County Emergency Medical Services personnel reached the hiker about half a mile into the Double Arch Trail.

The victim was removed from the area and transported to an area hospital for treatment.

The rescue team issued a safety reminder for anyone facing a similar situation in the backcountry:

"If you experience a snake- bite in the wilderness, remain calm, move a safe distance away from the snake, dial 911,

and stay on the line until emer- gency personnel reach you."

Copperheads are venomous snakes commonly found in Kentucky, and while their bites are rarely fatal when proper medical care is available, they can still cause serious pain, swelling, and other compli- cations that require prompt treatment.

Snakebites often happen when people move through the animals' habitat, especially at night when visibility is low and it is easy to step too close without noticing.

Precautions include stay- ing on marked trails, wearing sturdy boots, carrying a flash- light or head lamp, and staying alert for animals that may be hard to spot.
