KENTUCKY DEPARTMENT OF EDUCATION PROPOSED TAX NOTIFICATION

District: 595 Wolfe County

School Year: 2026-2027

The Wolfe County Board of Education is proposing a general fund tax levy of 41.8 cents on real property and 41.8 cents on personal property. The General Fund tax levied in fiscal year 2026 was 36.9 cents on real property and 36.9 cents on personal property and produced revenue of \$1,216,537. The proposed General Fund tax rate of 41.8 cents on real property and 41.8 cents on personal property is expected to produce \$1,563,036. Of this amount, \$334,115 is from new and personal property. The compensating tax for 2027 is 34.7 cents on real property and 37.2 cents on personal property and is expected to produce \$1,315,903. The proposed rate is expected to generate more revenue than received in the preceding year. The general areas to which revenue of \$346,499 above 2026 revenue is to be allocated to cost of collections, building fund, instruction, transportation, and maintenance. This information is published pursuant to KRS 160.470. The proposed tax rate is not subject to recall under KRS 132.017. The General Assembly has required publication of this advertisement and information contained herein.
